ORDER

WHEREAS, recognition was granted to the institution, namely, **Adarsh College of Education, P.O. – Dehar, Tehsil-Sunder Nagar, Distt. – Mandi, Pin code – 175030, Himachal Pradesh** vide Order No. F. NRC/NCTE/F-3/HP-211/24582-589 dated 16.08.2007 for conducting B.Ed. course of Secondary Level of one year duration with an annual intake of 100 (One Hundred Only) students.

AND, WHEREAS, the revised recognition order No. F.No./NRC/NCTE/HP-211/2015/111208-13 dated 05.06.2015 was issued to the institution for B.Ed. course for two basic units.

AND, WHEREAS, the institution submitted an application dt. 30.10.2015 to the NRC-NCTE for shifting of premises.

AND, WHEREAS, the case of the institution was considered by the NRC in its 248th Meeting of the NRC held on 11th to 20th, January, 2016 (Part-6, 18-19.1.2016). The Committee decided to constitute visiting team for conducting inspection for shifting of premises of the institution.

AND, WHEREAS, the inspection of the institution was conducted on 28.01.2015. The VTR was considered by the NRC in its 250th Meeting of the NRC (Part-1, 19-20.02.2016). The Committee decided as under: -

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.

Shifting of premises of Adarsh College of Education from P.O. Dohar, Sunder Nagar, Mandi to Plot No. 722, 1511 724, P.O. Amarpur, Ghumarwin, Bilaspur is allowed.”

AND, NOW, the institution namely **Adarsh College of Education** is hereby permitted shifting of premises from **P.O. – Dehar, Tehsil-Sunder Nagar, Distt. – Mandi, Pin code – 175030, Himachal Pradesh** to **Plot No. 722, 1511 724, P.O. Amarpur, Ghumarwin, Bilaspur, Himachal Pradesh** under clause 8(9) of the NCTE Regulations, 2014.
